SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures

General notes

Never give anything by mouth to an unconscious person. Place patient in recovery position and ensure airway patency. When in doubt or if feeling unwell seek medical assistance. Following inhalation

4.2 Most important symptoms and effects, both acute and delayed

Following inhalation

Excessive exposure to spray mist, fog, or vapours may cause respiratory irritation. Coughing, sneezing, nasal discharge, labored breathing.

Following skin contact

Skin burns: Signs/symptoms may include localised redness, swelling, itching, dryness, blistering.

Following eye contact

Redness, pain, burning sensation, tearing, can cause permanent damage to the eyes.

Following ingestion

May cause nausea/vomiting and diarrhea. May cause abdominal discomfort. If ingested, may cause burns of the mouth and throat, as well as perforation of the esophagus and stomach. Harmful to health.
